

## From Your President By Steve Beardslee

We are now underway in 2014, reviewing 2013 for lessons-learned, and looking for process improvements that make sense:

• Our PAE pilots are using Flight Schedule Pro, and thus far it appears superior to Schedule Master. Our Board members will familiarize themselves with Flight Schedule Pro, and determine whether or not to implement BEFA-wide, perhaps as early as March 1st. We think Flight Schedule Pro will save us money on

month-to-month subscriber fees, help us with improved visibility and tracking of squawks & maintenance, and provide better measuring of our flight operations performance. Please take a look at Flight Schedule Pro.

- The Feasibility Study team has determined that the risk of acquiring additional lease space on the Renton airport and building additional hangar space for rent to owners of small business jets owners is too great and would not be wise - at this point. This was not arrived at lightly, but our due-diligence argues clearly in favor of avoiding excessive risk to BEFA. It appears KBFI has now, perhaps has been overbuilt (rental prices are beginning to drop a bit); there is not sufficient reliable market demand information that would justify BEFA undertaking this kind of significant risk. However, the Feasibility Study team continues to evaluate other potential revenue sources, such as training (our BEFA core strength). We are looking for a way to improve our facilities at both Renton and Everett. Stav tuned.
- We continue the process of establishing a new non-profit organization that will act as a "public charity" and carry an IRS tax classification of 501(C)(3). We look to appoint the initial Board of Directors, and expect to gain Washington DOR and IRS approvals in 2014. This looks good.
- We continue the avionics upgrade of our aircraft to meet the FAA mandate for Automatic Dependent Surveillance Broadcast (ADS-B). We completed N5344K & N97PD in 2013, and will now upgrade another aircraft this month.
- We've completed the purchase of a 2003 Cessna 172S; N2164Z is now on the ramp at KPAE. Oliver Meyer & Steve Kirsch flew it home from Kentucky last week. Please take a look, schedule it, and fly it! This is a great addition to our BEFA fleet – Thanks Oliver for making this happen!
- This is our month to get N758NF operational with EDO 2440 floats I know, it's been far too long, but we're now almost there. We now need to re-energize

our float plane community. The seaplane dock area is now operational, thanks to the City of Renton.

Most of you know this, but there is the annual NW Aviation Conference and Trade Show at the Puvallup fairgrounds, Feb 22nd & 23rd. There are two items of importance here; first is the BEFA booth that we've done each year - this has been an enjoyable experience for those of us who've represented BEFA in the Booth. Glenn has posted a sign-up sheet for volunteers to man the booth; I encourage you to participate if you can -I've personally found this to be an enjoyable experience - and this has always benefited BEFA. #### MIXTURE CONTROL ON PREHEAT CARTS

Please remember that the same elements that apply to mixture control on airplanes also holds true with the preheat carts. We had a hose melt on the vertical preheat cart from the mixture setting being too high. If it's too hot, remember to 'enrichen' the mixture to lower the temperature to an acceptable level. ## The Cost of Freedom By Steve Isaacson

The February 2014 issue of "AOPA Pilot" magazine has an article titled "Fighting For Your Freedom." The photo of an armed Customs and Border Protection (CBP) officer standing next to a bulletproof vest-wearing German Shepherd makes it clear this is about something more than airport fess or a new gas tax.

The article is about what to do if approached by a law enforcement officer while operating on the ramp of an airport during a flight that is wholly conducted within the United States. What to do?

In short, remain calm, be courteous and respectful, and do not volunteer information. And even though as pilots we are required to present our certificate and photo id, you do not have to surrender any items or allow the plane to be searched.

AOPA ran the article because there's the possibility the CBP is occasionally over-stepping its authority.

I have mixed emotions on this issue.

On the one hand, I have nothing to hide. Search away.

On the other hand, this is America. Many have given their lives to protect your right and my right to be free from unreasonable search and seizure.

Uniformed officers with sunglasses and guns can be very intimidating. I don't know how I'll react if I'm ever confronted, but I downloaded the AOPA guidelines just in case and added them to my flight bag. You may want to do the same.
